CHARACTERISTICS

NEMguard®SC is a nematocide based on garlic extract that acts against free forms (ie Developmental stages in the soil and not within the plant tissues) of Galls nematodes from the genera *Meloidogyne*, and the others genera *Tylenchus*, *Trichodorus*, *Longidorus*, *Pratylenchus*, *Xiphinema*, *Globodera*, *Heterodera*.

APPLICATION AND DOSES OF USE

Apply NEMguard® SC at a dose of 2-4 L / ha to the growing soil using a suitable irrigation system, using water volumes per irrigation cycle between 1,000 and 30,000 L / ha. The best conditions for using the plant protection product are obtained when the soil is moist enough. It is therefore recommended to add the product to irrigation water towards the end of the irrigation cycle.

AUTHORIZED CROPS:

Solanaceae (tomato, peppers, eggplant): 2-4 L / ha. - Field and greenhouse use.

Period of use: from transplantation / sowing to harvesting.

Interval between interventions: 10-14 days.

Maximum number of interventions: 6 per crop cycle.

Cucurbitaceae with edible skins (cucumber, zucchini): 2-4 L / ha. - Field and greenhouse use.

Period of use: from transplantation / sowing to harvesting.

Interval between interventions: 10-14 days.

Maximum number of interventions: 6 per crop cycle.

Cucurbitaceae with non-edible skins (melon, watermelon, pumpkin): 2-4 L / ha. - Field and greenhouse use.

Period of use: from transplantation / sowing to harvesting.

Interval between interventions: 10-14 days.

Maximum number of interventions: 6 per crop cycle.
